BY ANHUI CONCH CEMENT COMPANY LIMITED**

This announcement is made by China Conch Venture Holdings Limited (the “**Company**”, which together with its subsidiaries are collectively referred to as the “**Group**”) on a voluntary basis.

As at the date of this announcement, the Group is directly interested in 49% equity interest in 安徽海螺集團有限責任公司(Anhui Conch Holdings Co. Ltd.*, “**Conch Holdings**”), which in turn is interested in approximately 36.40% equity interest in Anhui Conch Cement Company Limited (“**Conch Cement**”, Hong Kong Stock Exchange stock code: 00914, Shanghai Stock Exchange stock code: 600585). As disclosed in the Company’s annual results announcement for the year ended 31 December 2023 previously published, the Group derived a substantial portion of its profits for the two financial years ended 31 December 2022 and 2023 from its equity interests in Conch Holdings, an associate of the Group. During the abovementioned years, the share of profit of Conch Holdings accounted for approximately 72% and 67% of the Group’s profit from continuing operations, respectively.

Having taken into account the above factors, the board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company that Conch Cement published its 2024 first quarterly report (the “**Conch Cement 1Q2024 Report**”) containing its unaudited quarterly results for the three months ended 31 March 2024 on 26 April 2024. For further details, shareholders of the Company and potential investors are advised to refer to the Conch Cement 1Q2024 Report.
